director and director of the residential treatment facility in Rhinebeck, NY. He was appointed executive director/CEO in 2002 and provides overall leadership and direction to all of Astor's programs and services.

In addition to his board position with the New York State Coalition for Children's Behavioral Health, McGuirk was the chair of the Dutchess County Health and Human Service Advisory Committee and serves on other national and state committees that promote the health, welfare and rights of children and families, including the Steering Committee for the New York State Early Childhood Advisory Council, the New York State Early Intervention Coordinating Council and the Children and Family Advisory Committee for the Joint Commission. He also serves on the Boards of the Collaborative for Children and Families and the Children's Health Home of Upstate New York, two recently formed organizations by like-minded children's Human Services organizations that have been designated as Children's Health Homes in New York State.

McGuirk holds a doctorate in Counseling Psychology and a Bachelor of Arts in Psychology and Mathematics from the State University of New York at Albany. He resides in Glenmont, New York
